**Rocky Mountain Treatment Center** is seeking a highly motivated **LAC** to join our team. We are an adult inpatient drug and alcohol treatment center located in Great Falls, MT. **We are looking for someone who is passionate about helping individuals recover from addiction.**

As a Counselor at Rocky Mountain Treatment Center, you will work with individuals who have an addiction to alcohol and other drugs. You will counsel clients on issues related to addiction recovery. You will have direct contact with the client throughout their treatment which is normally 30 - 35 days.

You will be part of a team that includes counselors, nurses, and other staff. Other team members also include supervisors, treatment assistants and staff from the admissions department.

## Job Details:

1. Knowledge of federal, state and local laws pertaining to addiction counseling in a residential treatment setting.
2. Skill in written and oral communication including conflict mediation and creativity in working with a diverse population.
3. Ability to provide effective group and individual sessions.
4. Ability to maintain strict confidentiality.
5. Ability to teach a wide variety of topics suited for the specific needs of the clients.
6. Requires good physical health and ability to work flexible hours including overtime.
7. Working knowledge of ASAM criteria.

Responsible for providing professional, respectful and ethical individual and group counseling.

Responsible for functioning effectively with all other members of the clinical team as well as administrative and support staff.

Responsible to attend daily staffing.

Responsible for professionally assessing patient needs and making appropriate referrals for dual diagnosis, mental health, physician or continuing care needs.

Responsible for timely and accurate documentation of patient progress. This includes but is not limited to completion of bio psychosocial, treatment plan, progress notes, case presentation and discharge summary all based upon ASAM criteria.

Participate in educating patient and family to the disease of addiction.

Meet weekly with case manager for continued stay review of current patient load.

Assist with education and training of all newly hired treatment assistant, counselors.

Responsible to complete annual continuing education requirements and population specific education.
